A. AL2013-060, Bio-Medical Applications of Alabama, Inc. d/b/a Fresenius Medical Care Foley, Foley, AL: Proposes to expand by adding an additional six (6) hemodialysis stations to the existing facility consisting of nine (9) hemodialysis stations and one (1) isolation station. **Opposition: None**

B. AL2013-061, Renal Treatment Centers-Southeast, LP d/b/a Jewel Dialysis, Bessemer, AL: Proposes to add two (2) hemodialysis stations at its current location consisting of seven (7) hemodialysis stations and one (1) isolation station. **Opposition: None**

C. AL2013-062, Flor Dialysis, LLC d/b/a Steel City Dialysis, Birmingham, AL: Proposes to add two (2) hemodialysis stations at its current location consisting of seven (7) hemodialysis stations and one (1) isolation station. **Opposition: None**

D. AL2013-063, RAI Care Centers of Alabama, LLC, Jacksonville, AL: Proposes to add four (4) hemodialysis stations and two (2) home training stations to the existing twelve (12) station facility. **Opposition: None**

- E. AL2013-064, DCI Evergreen, Evergreen, AL:** Proposes to add two (2) additional stations to the existing ten (10) stations, one of which is an isolation station for Hepatitis-B surface antigen positive patients, for a total of twelve (12) stations. **Opposition: None**
- F. AL2013-065, DCI Mitylene Park, Montgomery, AL:** Proposes to add one (1) home training station to the existing sixteen (16) stations, one of which is an isolation station. **Opposition: None**
- G. AL2013-066, Village at Cook Springs, LLC, Pell City, AL:** Proposes to establish a twenty-eight (28) bed specialty care assisted living facility on the campus of Village East by relocating twenty-six (26) SCALF beds from The Village at Cook Springs, fifteen (15) authorized by CON 2623-SCALF, eleven (11) existing beds, and add two (2) new beds. **Opposition: None**
- H. AL2013-067, Renal Treatment Centers-Southeast, LP d/b/a North Jefferson Dialysis, Birmingham, AL:** Proposes to establish and operate a new ESRD facility in north Jefferson County consisting of two (2) existing in-center hemodialysis stations to be relocated from DaVita's Birmingham East Dialysis, plus add eight (8) new in-center hemodialysis stations. **Opposition: None**
- I. AL2013-068, Jackson Hospital and Clinic, Inc., Montgomery, AL:** Proposes to add a third cardiac catheterization laboratory, located adjacent to the two existing cardiac cath rooms within the hospital. **Opposition: None**
