**A. Project Modification**

**AL2015-014, The Health Care Authority of Cullman County d/b/a Cullman Regional Medical Center, Inc., Cullman, AL:** Proposes to relicense thirty acute care beds that were previously acquired through CON 2278-H-E. CON 2710-H was issued April 2, 2015. **Project Modification Request:** Increase in the project cost from \$877,882.00 to \$14,920,000.00.

- B. AL2016-001, Sylacauga Health and Rehab Services, LLC, Sylacauga, AL:** Proposes to establish a forty (40) bed Specialty Care Assisted Living Facility by converting thirty-six (36) assisted living beds to specialty care assisted living beds and add four (4) new SCALF beds.  
**Opposition: None**

- C. AL2016-002, Randolph County Health Care Authority, Roanoke, AL:** Proposes to replace and relocate the thirty-four (34) bed general acute care Wedowee Hospital. The project will result in the reduction of nineteen (19) acute care beds in Randolph County. **Opposition: None**

- D. **AL2016-003, The Health Care Authority of the City of Huntsville d/b/a Huntsville Hospital, Huntsville, AL:** Proposes to construct two (2) new catheterization labs, plus the conversion of one (1) existing EP lab to a Dual Purpose Lab and one (1) existing EP lab to a Multi-Purpose lab for a total number of catheterization labs to ten (10). **Opposition: None**
- E. **AL2016-004, Gulf Health Hospitals d/b/a Thomas Hospital, Fairhope, AL:** Proposes to construct new space on the 4th floor to accommodate the existing Birthing Center's relocation to the new space, which will include fifteen (15) new postpartum rooms, eight (8) labor and delivery rooms, two (2) operating rooms and a dedicated triage area. **Opposition: None**
- F. **Contested Case Withdrawn, Remanded by ALJ**  
**AL2015-040, The Phoenix at Madison, LLC, Madison, AL:** Proposes to lease and operate a new twenty-four (24) bed Specialty Care Assisted Living Facility. **Opposition: Heritage Assisted Living and Memory Care, LLC d/b/a Heritage Memory Care withdrew Request for a Contested Case Hearing December 17, 2015.**
- G. **Contested Case, Batched Applications**  
**AL2015-008, Hope Hospice, Inc., Birmingham, AL:** Proposes to construct a freestanding inpatient hospice facility consisting of ten (10) beds in Region V. ALJ filed Recommended Order denying this project. **Opposition: Optum Palliative and Hospice Care, Inc. filed intervention, opposition and request for contested case hearing.**
- AL2015-009, Alacare Home Health Services, Inc. d/b/a Alacare Home Health & Hospice, Birmingham, AL:** Proposes to construct a new fourteen (14) bed inpatient hospice facility in Region V. ALJ filed Recommended Order approving this project. **Opposition: Optum Palliative and Hospice Care, Inc. filed intervention, opposition and request for contested case hearing.**
