**A. Declaratory Ruling 149:**

Providence Hospital, Infirmary Health System, Inc. d/b/a Mobile Infirmary Medical Center, and Springhill Hospitals, Inc. d/b/a Springhill Memorial Hospital has submitted a Petition for Declaratory Ruling, requesting that the CON Review Board reverse the reviewability determination (RV2014-028), dated March 16, 2016, issued by the Executive Director of the Alabama State Health Planning and Development Agency (“SHPDA”) regarding the proposal by Surgicare of Mobile, Ltd. (“Surgicare”) to expand its existing ambulatory surgery center (“ASC”) in Mobile, Alabama.

**B. Declaratory Ruling 150: Withdrawn April 18, 2016**

Anniston HMA, LLC d/b/a Stringfellow Memorial Hospital submitted a Petition for Three Declaratory Rulings, requesting that the CON Review Board issue the following separate declaratory rulings:

1. Board’s interpretation of the “appropriate applicant” rule codified at Ala. Admin. Code r. 410-1-6-.09, including whether the Board’s determination of an “appropriate applicant” includes evidence of an applicant’s compliance or lack of compliance with Alabama law.
2. Whether Regional Medical Center Board d/b/a Northeast Alabama Regional Medical Center (“RMC Anniston”) should be required to make a witness available to testify on behalf of the hospital at an upcoming administrative hearing regarding relevant areas of inquiry under Ala. Admin. Code r. 410-1-6-.09, as requested in Stringfellow’s subpoena.
3. Whether RMC Anniston should be required to produce documents prior to an upcoming administrative hearing regarding relevant areas of inquiry under Ala. Admin. Code r. 410-1-6-.09, as requested in Stringfellow’s discovery.
