The next three projects have been put on the agenda for **informational purposes only**. No vote is required because, "the recommended order of the Administrative Law Judge becomes the final order of the Agency when no exceptions have been filed." No exceptions were filed. The projects were approved through a Settlement Agreement between the three (3) parties.

Contested Case

AL2017-018, Huntsville Senior Services, LLC d/b/a Regency Remembrances, Huntsville, AL: Proposes to add thirty-two (32) specialty care assisted living beds to an existing seventy-two (72) bed SCALF. The ALJ approved this project for ten (10) beds.

AL2017-019, LC Big Cove, LLC, Hampton Cove, AL: Proposes to construct a new thirty-two (32) bed Specialty Care Assisted Living Facility. The ALJ approved this project for twelve (12) beds.

AL2017-020, Shepherd Living at The Range, LLC, Madison, AL: Proposes to establish a thirty-two (32) bed Specialty Care Assisted Living Facility through the conversion of thirty-two (32) assisted living beds. The ALJ approved this project for ten (10) beds.

- A. **AL2017-034, NHC HealthCare/Moulton, LLC d/b/a NHC HealthCare Moulton, Moulton AL:** Proposes to add outpatient multidisciplinary therapy services consisting of respiratory, physical, speech and occupational therapies. **Opposition: None**
- B. **AL2017-035, TPC Properties, LLC, d/b/a The Olive Home, Inc.-Oneonta #2, Oneonta, AL:** Proposes to add sixteen (16) specialty care assisted living facility beds to the existing eighteen (18) bed SCALF through the conversion of sixteen (16) assisted living facility beds. **Opposition: None**
- C. **Contested Case**
AL2017-021, Alabama Eye Surgery Center, LLC, Dothan, AL: Proposes to establish a single-specialty ambulatory surgery center specializing in ophthalmic surgeries such as glaucoma and cataract. Administrative Law Judge submitted Recommended Order of Approval. **Opposition: Dothan Surgery Center and Southern Alabama Surgery Center, LLC d/b/a Surgery Center South filed Opposition/Intervention and Request for a Contested Case Hearing. Dothan Surgery filed Notice of Withdrawal of Intervention and Opposition August 30, 2017. Exceptions were filed by Southern Alabama Surgery Center, LLC d/b/a Surgery Center South October 2, 2017.**
- D. **Contested Case**
AL2017-016, The East Alabama Health Care Authority d/b/a East Alabama Medical Center, Opelika, AL: Proposes to expand ambulatory surgical services by operating, at an off-site location, via a facility lease, a multi-specialty ambulatory surgery center consisting of four (4) general anesthesia operating rooms, two (2) procedure rooms and support space. Administrative Law Judge submitted Recommended Order of Approval. **Opposition: Doctors Surgery Center of East Alabama, LLC filed Opposition/Intervention and Request for a Contested Case Hearing. Exceptions were filed by Doctors Surgery Center of East Alabama, LLC October 6, 2017.**
