A. Project Modification

AL 2016-022, Geneva County Health Care Authority, Inc., Geneva, AL:

Proposes to acquire, relocate and operate five (5) geriatric psychiatric inpatient beds as an addition to its existing sixteen (16) bed geriatric psychiatric unit. These beds will be relocated from the now closed Chilton Medical Center.

Project Modification Request: Increase in the project cost from \$110,500.00 to \$232,351.13, a result of new management and new architectural firm. **Opposition:** Laurel Oaks opposes any attempt to change the limiting language set out in the original CON.

B. AL2017-039, Bio-Medical Applications of Alabama, Inc. d/b/a RCG Clanton, Clanton, AL:

Proposes to expand the existing twelve (12) station ESRD Dialysis Treatment Center by adding nine (9) in-center hemodialysis stations, resulting in a total of twenty-one (21) in-center stations, including one (1) isolation station.

C. AL2017-040, Bio-Medical Applications of Alabama, Inc. d/b/a FMC Dialysis Services of Lakeview, Guntersville, AL:

Proposes to relocate the existing seventeen (17) station ESRD Dialysis Treatment Center to a nearby location and to expand the facility through the addition of seven (7) in-center hemodialysis stations and change the trade name to Kidney Care Arab. **Opposition: None**

- D. **AL2017-043, Deese & Maxey, P.C., Mobile, AL:** Proposes to expand the existing physical therapy service by adding speech and occupational therapy services, as well as a specialized pelvic health program. **Opposition: None**
- E. **AL2017-044, LP Vestavia, LLC d/b/a Longleaf at Liberty Park, Vestavia Hills, AL:** Proposes to acquire and relocate thirty (30) specialty care assisted living beds, sixteen (16) from Vestavia Hills, Ltd. and fourteen (14) from Birmingham Senior Services, LLC, contingent upon the approval of this project. **Opposition: None**
- F. **AL2018-001, Physicians Choice Dialysis of Alabama, LLC d/b/a PDI Prattville Dialysis, Prattville, AL:** Proposes to relocate and expand its existing sixteen (16) in-center hemodialysis station facility to a nearby location from the current location, and expand the facility through the addition of one (1) separately licensed isolation station for a total of seventeen (17) licensed stations. **Opposition: None**
